Kent Island Federation of Arts, Inc. (KIFA) presents quilted fabric works that reflect the inspirations of the artists.

Artists may enter **up to three works**, in the following Categories: **Modern/Contemporary, Traditional, Applique, Garments and Accessories.**

Guidelines: All quilts must be prepared to hang with attached rods. Size will be restricted to no more than 40" wide and no more than 60" deep. No bed-sized quilts.

All work must be original, not shown previously at KIFA, created within the past two years and not infringe upon any copyright. KIFA reserves the right to reject works deemed unsuitable. All entered works must remain on display through the end of the show.

Reasonable care will be taken to ensure the safety of your artwork. KIFA is not liable for loss or damage to artwork.

Pre-Registration is required. A non-refundable fee must be included with registration.

KIFA's commission on all sales is 25%. KIFA reserves the right to use images of the winning artwork for up to eighteen months.

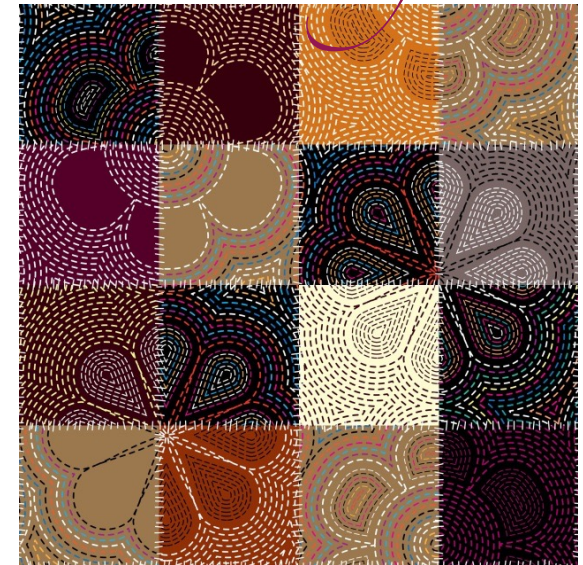
